I asked the occupants when marijuana had been last smoked in the vehicle to which the passenger stated it had been the previous morning.</p> <p>I asked the occupants to step out and performed a probable cause search of the vehicle. I located the burnt remainder of a green leafy substance wrapped in tobacco in the right rear floorboard behind the front passenger seat. Due to my training and experience, I recognized the green leafy substance as marijuana.</p> <p>I read the occupants their Miranda Rights which they stated they understood. Neither occupant claimed ownership of the marijuana. The driver was issued a written warning for operating a motor vehicle with expired plates and a misdemeanor citation for possession of marijuana with the attached court date and time. Both occupants and the vehicle were released on scene.</p> <p>I weighed the burnt remainder of a green leafy substance on a digital scale which produced a field weight of 0.3 grams. I field tested the green leafy substance with a Duquenois-Levine Reagent Test which yielded a positive result for THC. I placed the burnt remainder of a green leafy substance into a labelled evidence bag which I deposited at EPD Headquarters.</p>		PAPE, N. A.
