The driver was issued a misdemeanor citation for possession of marijuana with the attached court date and time as well as written warnings for improper lane movement and his seatbelt violation. The driver and vehicle were released on scene. Officers weighed the green leafy substance on a digital scale which produced a field weight of 29.6 grams. Officers field tested the green leafy substance with a Duquenois-Levine Reagent test which produced a positive result for THC.
