It was causing the officers to feel sick to their stomach. Officers informed him they were not there for the generator, but to follow up on an animal complaint. The girlfriend led the officers and AC to where the dog was laying stating it had plenty of food and water. Officers walked towards the dog and began to whistle to get the dog to lift its head, but it laid there. The girlfriend began to yell "Blacky", the dogs name, and the dog barely moved. Officers observed Blacky to be extremely matted. Blacky was turning gray from the dirt and filth piling on the matts. The matts appeared to be covering 75 percent or more of his body. Officers asked the owner if he understood what matting on a dog does, and he stated he knew. Matting can lead to extreme pain, skin infections, and hotspots. He then responded with Blacky doesn't have much longer anyways and that he is tired of people sticking their nose into his business. The male began to get verbally aggressive with officers as they explained again why they were there and the conditions of Blacky. The male stuck his hands in his pockets and began to blade his body, in a fighting stance. The male continued to argue with officers and eventually sat on the couch. The male was told officers would be taking his dog and he was getting a citation. He continued to argue and stated the dog had been like that for three plus months. AC began to speak and he began to yell at them. Officers decided he was going to jail and force was used to take him into custody.
